

Dear Neighbor,

I'd like to thank the City of Kansas City for sponsoring a second fall clean up convenient for residents in my district last Saturday, October 23, with four different drop off sites.

The 5th Council District Fall Clean Up collected 55 tons of bulky items such as old furniture, leaves & brush and trash, 2,823 pounds of electronics for recycling and 1,640 tires. It also accepted and shredded 5 tons of documents and other paper.

This was more bulky items, leaves & brush and trash and more tires than collected at the October 2 6th Council District Clean Up on October 2, but less electronics and shredding.

The 5th District Clean Up was sponsored by City Council members Lee Barnes, Jr., and Ryana Parks-Shaw and conducted and organized by the City Public Works and Neighborhoods & Community Services Departments.

The great majority of my district is in the 6th Council District, but some of it is in the 5th District.

I'd also like to thank the **Mid-Continent Public Library** for the extensive renovation of its **Blue Ridge Branch** just blocks away from my district which is expected to be complete before the end of the year.

Welcome new amenities will include a large community meeting room and smaller meeting rooms. The new Red Bridge Branch in my district has similar meeting facilities which are a great convenience for the community.

I'm also very pleased that ALPLA North America, a leading manufacturer of bottles, caps, other plastic packaging and molded parts will begin construction later this year of a 246,000 square foot injection molding manufacturing facility expected to create about 75 new jobs at the Blue River Commerce Center on the site of the former Bannister Federal Complex on the north side of Bannister Rd. east of Troost. Construction is expected to be completed in late 2022.

The Commerce Center is being developed and managed by NorthPoint Development.

Also, don't miss the announcement further down in the Report about a virtual community meeting from 6 to 8 p.m. Wednesday, November 10, about design concepts for proposed streetscape improvements to Blue Ridge Blvd. from 87th St. to Bannister Rd. as well as design concepts for possible future improvements to Bannister Rd. from I-435 on the west to Highway 350 on the east.

Senior citizens should be sure to look at the welcome announcement later in the Report that Jackson County is continuing its program that allows home owners who will be 62 or over by December 31 to apply to be allowed to pay their county real estate taxes on the homes they live in with four equal installment payments without interest or penalties. The payments will be due December 31, February 28, May 31 and August 31.

To qualify, senior home owners must have paid their real estate taxes for all prior years and not be delinquent, and their homes must be assessed solely as residential property.

MARIJUANA SCORING FIRM LOSES ARBITRATION

The company Gov. Mike Parson's administration hired to review applications for licenses to grow, manufacture or dispense medical marijuana in Missouri has lost a \$28 million arbitration award in a case brought by one unsuccessful applicant, the St. Louis Post-Dispatch reported Oct. 26.

Missouri voters ratified a constitutional amendment in 2018 legalizing medical marijuana and putting the Missouri Department of Health and Senior Services in charge of regulating the industry.

The department hired Wise Health Solutions to score the license applications. The department used the scores to determine which applicants should be awarded one of the limited number of licenses available.

Wise's scoring methodology has been widely criticized as inconsistent and allegedly favoring clients of an affiliated consulting firm. Thousands of administrative appeals have been filed challenging the department's rejection of license applications.

GMT Consulting, which unsuccessfully sought four licenses to operate in the St. Louis area, went a step further and sued Wise in 2020, claiming the company's scoring process was "corrupt", according to the Post-Dispatch. The case was sent to arbitration, with GMT prevailing. Buchanan County Circuit Judge Kate Schaefer entered a judgment confirming the \$28 million arbitration award on July 26.

GMT filed a subsequent lawsuit in Cole County Circuit Court on Aug. 18 seeking enforcement of the award against Wise's insurance provider. No hearing has been set yet in that case, *GMT Consulting LLC v. Hiscox Insurance Company Inc.*

SCHMITT CHANGES STORY ABOUT BORDER TRIP

Two days after saying taxpayers footed the bill for his recent trip to the Texas/Mexico border, Missouri Attorney General Eric Schmitt reversed course and said his U.S. Senate campaign paid his travel expenses, the Kansas City Star reported on Oct. 24.

However, Schmitt's spokesman in the Attorney General's office also went on the trip and said taxpayers did cover his costs, raising questions of whether public money was used to send a state employee to a campaign event.

Schmitt went to El Paso, Texas, on Oct. 20 to join Texas Attorney General Ken Paxton for a news conference announcing a lawsuit they are filing in a longshot effort to force President Joe Biden to resume construction of the controversial border wall championed by former President Donald Trump.

It is just the latest is a string of lawsuits of uncertain legal merit on hotbutton conservative issues Schmitt has filed as he seeks election to the U.S. Senate seat in a crowded GOP primary.

Schmitt, through his spokesman, originally defended using taxpayer funds for the trip, claiming the lawsuit was filed on behalf of Missourians to protect their interests, the Star reported on Oct. 21. But two days later, the spokesman backtracked, saying his original comments were based on a "miscommunication".

Rather than mitigating criticism against Schmitt for using taxpayer resources for the trip, the change in position served to intensify that criticism.

Saying his campaign actually paid for Schmitt's travel seemed a tacit admission of the trip's campaign purpose and made the propriety of bringing along a state employee at taxpayer expense appear even more questionable.

PARSON PICKS ASSISTANT AG FOR COURT VACANCY

Gov. Mike Parson on Oct. 22 appointed First Assistant Attorney General

Cristian Stevens to the Missouri Court of Appeals Eastern District. Stevens, who resides in Kirkwood, replaces Judge Robin Ransom, who moved up to the state Supreme Court earlier this year.

Stevens was one of three finalists chosen by the Missouri Appellate Judicial Commission to fill the vacancy on the St. Louis-based court. The others were private practice attorneys Kathleen Hamilton of St. Charles and Jeffery McPherson of Webster Groves.

Parson has two more pending appellate appointments to make. The commission has already sent him finalists for a vacancy in the Kansas City-based Western District. The commission is to meet Nov. 22 to select finalists for an opening in the Springfield-based Southern District.

Once he fills those slots, Parson will have appointed 10 of the members of the state Court of Appeals, which has 32 members split across its three districts.





Blue Ridge Boulevard Streetscape Improvements: 87th Street to Bannister Road

The Blue Ridge Boulevard Improvement Project consists of design of improvements along Blue Ridge Boulevard from 87th Street to Bannister Road.

The goal of the project is to design infrastructure and streetscape improvements that will serve the needs of the surrounding community. The hope is that these improvements will spur redevelopment along this corridor and improve connections to area businesses and services.

Blue Ridge Boulevard is an important connector in Kansas City. The project includes commercial nodes at 87th Street and Bannister Road, with residential areas in between - including the Loma Vista neighborhood. Blue Ridge Boulevard is currently four lanes with a center turn lane at the commercial nodes at 87th and Bannister Rood.

Bannister Road Corridor Study

The Bannister Road Corridor study area is 7 miles long, spanning from I-435 on the west to State Route 350 on the east. The study team is working with community members and others through 2021 to review previous recommendations, understand current issues and desires, develop concepts, identify a preferred alternative, and estimate improvement costs. Currently, no funding is available for design and construction of recommended improvements, but continued planning is necessary for Bannister Road's future if and/or when funding becomes available.



Real Estate Tax Bill Can Be Spread Over 4 Payments Senior Citizen Quad Payment Program

The Senior Citizen Quad Payment Program gives Jackson County seniors the option to pay their County real estate tax bill in four equal installments -- without interest or penalties applying. The installment payments are due December 31 of the tax year and then February 28, May 31 and August 31 of the following year.

Quad Payment Deadlines For Tax Bills

December 31 February 28 May 31 August 31

This program does not apply to non-real estate taxes.

To qualify...

- · You must be 62 or older by December 31 of the tax year.
- You must live at the address which you desire to have covered by the installment option.
- You (not a trust) must own this real estate in fee simple or as a co-tenant, by tenancy in common, joint tenancy or tenancy by entirety.
- · All prior year taxes must be paid and not be delinquent.
- · The property is assessed solely as a residential property.
- You must apply for the program and meet all requirements to remain in the program.

Persons should take the Troost Ave exit. The event is sponsored by the Center Education Foundation in partnership with the Center School District.

Evangel Church, 1414 E. 103rd St., from 7 to 8:30 a.m. the second Saturday of the month. Persons may remain in their vehicles, and food will be brought to them.

United Believers Community Church, 5600 E. 112th Terr., with vehicles lining up at 8:30 a.m. and contactless food distribution running from 9 to 11 a.m. the third Wednesday of the month.

Ruskin High School, 7000 E. 111th St., from 4 to 5:30 p.m. the third Thursday of the month. Vehicles should line up on Ruskin Way on the east side of the school, and staff and students will load the food when vehicles reach the school. Colonial Presbyterian Church, 9500 Wornall Rd., with registration beginningat 8 a.m. and food distribution running from about 8:30 to 10 a.m. on the thirdSaturday of the month.Families are asked to bring two cardboard boxes forvolunteerstoputthefoodin.

Center School District, 8701 Holmes Rd., from 11 a.m. to 1 p.m. as long as food is left on the third Saturday of the month. Persons should drive through the bus parking lot to the district warehouse. The event is sponsored by Three Trails Community church in partnership with the Center School District.
