



Dear Neighbor,

Persons who still have not received their COVID-19 vaccinations or who have friends and family who haven't should take advantage of a virtual presentation of the latest news about the availability of vaccinations in our area and the state at **6 p.m. Monday, April 12.**

At my request, **Dr. Randall W. Williams, MD, director of the Missouri Department of Health & Senior Services**, agreed to bring the latest news about vaccination availability to a ZOOM webinar from 6 to 7:30 p.m. hosted by the South Kansas City Alliance.

Dr. Williams is scheduled to be the first presenter and has agreed to accept questions as time allows. He will be joined by **Dr. Rex Archer, MD, director of the Kansas City Health Department**, so the top two health officials of the city and state will be able to give area residents authoritative answers to their questions about the vaccination program.

Today, **Friday, April 9**, is the first day of Phase III of Missouri's vaccination schedule which allows all Missourians to qualify for the vaccinations if they are 16 or older or 18 or older depending on what type of vaccine they will be getting.

While mass vaccination events recently either have been conducted or announced for our area at Smith-Hale Middle School at the former Hickman Mills High School and at Grandview High School, I will do my best to continue to advocate for more of such events and sites that will provide daily vaccinations on an ongoing basis in our area where our vaccination rates are still too low.

In the past weeks and months many residents of our area who wanted to be vaccinated have had to drive to cities and towns outside our metropolitan area or other parts of our city. Hopefully, that is ending!

## **WEEKLY CAPITOL UPDATE**

Friday, April 9, 2021

**HOUSE APPROVES NEW DEFENSE DEPARTMENT**

The House of Representatives voted 146-6-1 on April 8 to pass House Joint Resolution 6 -- a proposed constitutional amendment that, if ratified by voters, would create a new state Department of Defense to oversee the Missouri National Guard which currently is under the Department of Public Safety.

The House also approved companion implementing legislation (House Bill 60) by a vote of 132-15-3. I voted for both measures.

**The sponsor of HJR 6 said the intent of placing the National Guard under its own state department is to streamline the chain of command by having the state adjutant general report directly to the governor instead of to the public safety director.**

Both HJR 6 and House Bill 60 now are awaiting Senate consideration. If the upper chamber passes HJR 6, the proposed constitutional amendment will automatically go on the November 2022 statewide ballot for voter ratification. If voters reject it, HB 60 would be rendered inoperable.

At present, the state has 16 state departments, the maximum authorized under the state constitution.

### **KC, STL VOTERS RENEW EARNINGS TAXES**

Voters in both Kansas City and St. Louis City on April 6 again overwhelmingly supported renewing their local earnings taxes for another five years starting on January 1, 2022, by over three to one margins, with Kansas City voters approving continuation of the tax by 77.3% and St. Louis City voters approving continuation by 79.4%.based on unofficial election results.

**Kansas City's 1 percent earnings tax is assessed on wages earned by residents and persons who work in the city but live elsewhere including visiting professional athletes who are assessed the taxes on their earnings while playing here. Historically, about half of Kansas City's e-tax revenue comes from people who work in the city but live outside the city limits.**

The tax which is the city's largest single source of revenue also is assessed on the net profits of businesses located in the city or doing business here. Last year about 18% of Kansas City's e-tax revenue came from business profits.

Pension and Social Security payments aren't subject to the tax, and neither are disability and unemployment payments.

Kansas City's earnings tax went into effect in 1964 when it was just a half percent, and voters approved raising that to 1 percent in 1970.

**Then in 2010, St. Louis multimillionaire Rex Sinquefield helped bankroll a successful statewide ballot initiative to require Kansas City and St. Louis City to put renewal on the ballot every five years. If the tax is ever not renewed it would be phased out over 10 years and could not be reinstated.**

This was the third renewal vote required under the 2010 law, and none of the results have been close in either city. Continuation of Kansas City's e-tax won 78% approval in 2011 and 77% approval in 2016.

**Placing the city's single biggest source of revenue in doubt every five years causes the city to pay higher interest rates when it issues bonds to finance needed capital improvements such as street and bridge construction and reconstruction. The burden of those higher interest charges ultimately falls on city taxpayers.**

That's why I cosponsored the bipartisan bill introduced by Representative Brenda Shields to only require renewal every ten years. So far this session there has been no progress on this legislation, but after the third overwhelming approval of continuation of the e-tax in both cities, perhaps this proposal now will get serious consideration.

### **HOUSE MOVES TO EXEMPT STIMULUS CHECKS**

The House of Representatives on April 7 granted first-round approval on a voice vote to legislation that would exempt the recent federal stimulus payments – and any additional such payments that Missourians might

receive in the future – from being subject to state income taxes.

A second, recorded vote is required to advance the bill to the Senate.

**Because the purpose of federal stimulus payments is to immediately inject money into the economy through increased individual spending, it has been the practice for Missouri lawmakers to exempt such payments from state taxation in order to maximize the economic benefit.**

The tax exemption measure, which I support, is House Bill 991.

### **PARSON PICKS EX-LAWMAKER FOR PSC**

Gov. Mike Parson on April 1 nominated former state representative Glen Kolkmeier, an Odessa Republican, for a coveted position on the Missouri Public Service Commission, the regulatory authority for investor-owned utilities operating in Missouri. The Senate must confirm his appointment before Kolkmeier can join the commission.

All five current members of the PSC have served in either the Missouri House of Representatives, the state Senate or both.

**Kolkmeier, who termed out of the House in January after serving eight years, is nominated to replace Republican Bill Kenney, a former state senator from our area. Kenney's term expired more than three years ago, but he continues to serve until a successor is nominated and confirmed.**

Parson at any time can also replace a second Republican commissioner whose term expired more than a year ago.

**Dr. Archer** is a past president of the National Association of County and City Health Officials. Under his leadership, KCMO's

Health Department has twice won that organization's Local Health Department of the Year award.

**Kansas City Police Chief Rick Smith** will speak on the webinar about the Police Department's ongoing deployment of body cameras to its officers and policies for their use which require them to be on during every contact with the public.

The Department's policy prohibiting officers from using non-lethal weapons and munitions (other than chemical agents) to disperse crowds during unlawful assemblies also will be explained by Chief Smith. The policy notes officers "will make all reasonable efforts to allow law-abiding individuals to continue to exercise their First Amendment-protected rights."

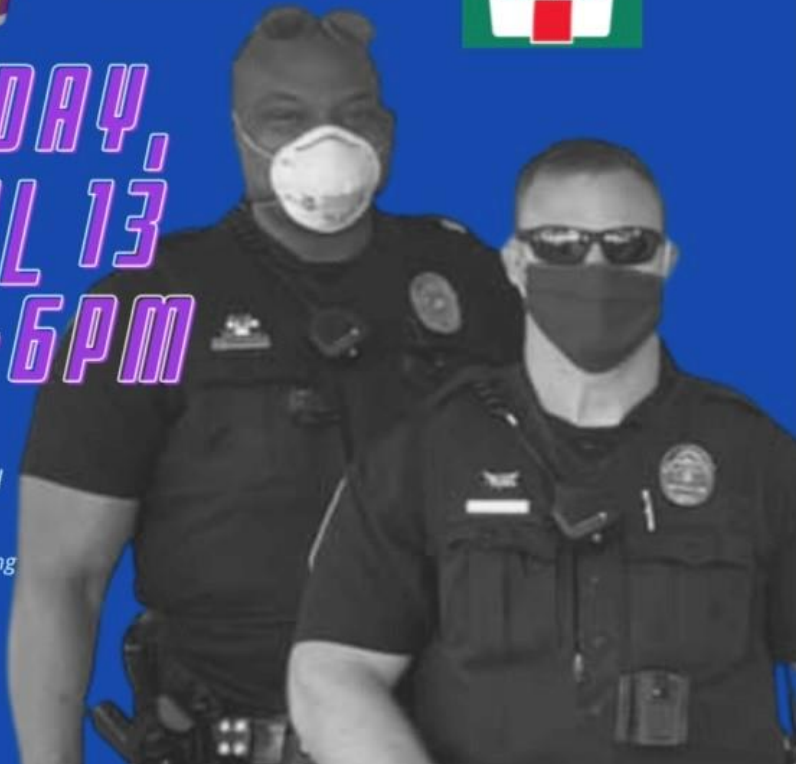

Application Now Open**

[The Neighborhoods Rising Fund \(NRF\)](#), a grant program for

revitalizing neighborhoods, relaunched today, thanks to a donation from H&R Block (NYSE: HRB) as the primary corporate partner to bring more revitalization to neighborhoods throughout Greater Kansas City. The relaunched NRF is supporting an expanded geographic area, an increased award cap for its one-year grants, and new, two-year award options.

The NRF's newly expanded geographic area includes Jackson, Clay, Platte, and Cass counties in Missouri, as well as Wyandotte, Johnson, and Leavenworth counties in Kansas, with a specific focus on historically underinvested neighborhoods in these seven counties, which is also CCF's newly broadened service area.

***The award cap for this year's one-year grants increased from \$3,000 to \$5,000, giving neighborhoods with additional capacity an opportunity to expand their programming.***

Also, this year the NRF includes two-year award options of up to \$5,000 per year for applicants that have satisfactorily completed and reported on any prior NRF-funded projects.

Administered by the Community Capital Fund (CCF), the Neighborhoods Rising Fund (NRF) is a funding collaborative that provides grants for high-impact, innovative community projects and neighborhood revitalization initiatives, which help build stronger, better connected and more effective neighborhood organizations in low- to moderate-income areas, throughout the Greater Kansas City Metropolitan Area.

The state of Missouri's new rental assistance program using funding through the Emergency Rental Assistance Program (ERAP) was passed by Congress in December 2020. On February 11, 2021 Governor Parson signed HB 16 into law, which provides more than \$324 million in funding for rental and utility assistance for Missourians. ## South KC Mobile Food Pantries

With so many people out of work due to the coronavirus pandemic, a growing number of families in south Kansas City are being forced to rely on community food pantries such as Community Assistance Council's to have enough to eat.

Fortunately, Harvesters (the community food network) brings the semi-truck that serves as its mobile food pantry to five sites in south Kansas City monthly to distribute fresh produce and other healthy food to families in need. The sites are:

**Center District Warehouse**, 8701 Holmes Rd., from 11:30 a.m. to 1:30 p.m. the second Friday of each month. Persons should go to the entrance to the Center Administrative Office and drive through the bus parking lot to the warehouse where volunteers will load the food. Persons should take the Troost Ave exit. The event is sponsored by the Center Education Foundation in partnership with the Center School District.

**Evangel Church**, 1414 E. 103<sup>rd</sup> St., from 7 to 8:30 a.m. the second Saturday of the month. Persons may remain in their vehicles, and food will be brought to them.

**United Believers Community Church**, 5600 E. 112th Terr., with vehicles lining up at 8:30 a.m. and contactless food distribution running from 9 to 11 a.m. the third Wednesday of the month.

**Ruskin High School**, 7000 E. 111<sup>th</sup> St., from 4 to 5:30 p.m. the third Thursday of the month. Vehicles should line up on Ruskin Way on the east side of the school, and food will be loaded in the vehicles when they reach the school by staff and student volunteers. This event is sponsored by the school and Community Assistance Council.

**Colonial Presbyterian Church**, 9500 Wornall Rd., with registration beginning at 8 a.m. and food distribution running from about 8:30 to 10 a.m. on the third Saturday of the month. Families are asked to bring two cardboard boxes for volunteers to put the food in.

**Center High School**, 8715 Holmes Rd., from 11 a.m. to 1 p.m. as long as food is left on the third Saturday of the month. The event is sponsored by Three Trails Community church in partnership with the Center School District.
