

Dear Neighbor,

I filed the following five bills on December 1 for consideration during the 2022 regular session of the Missouri General Assembly that starts January 5.

**House Bill 1568** – Cited as Blair's Law to commemorate the life of 11-yearold Blair Shanahan Lane who died soon after being struck by celebratory gunfire here on July 4, 2011, makes discharge of a firearm within or into city limits with criminal negligence a state offense.

**House Bill 1569** – Allows any individual found guilty of a felony and imprisoned to apply for restitution of \$100 a day for each day of post-conviction imprisonment if the person is later determined to be actually innocent and exonerated. Currently restitution is only available to persons who are exonerated based solely on DNA analysis.

**House Bill 1570** – Provides a tax credit of up to 50% of a person's eligible expenses for establishing an urban farm (including a community-run garden) in a food desert that is not close to a full-service grocery store. An individual's tax credit is limited to \$1,000 per urban farm.

**House Bill 1679** – Establishes a sales tax exemption for diapers defined as "absorbent garments worn by infants or toddlers who are not toilet-trained or by individuals who are incapable of controlling bladder or bowel movements".

**House Bill 1680** – Requires persons to temporarily use an ignition interlock device on their vehicles that prevents the vehicle from starting if the person is intoxicated after conviction for an intoxication-related traffic offense. Currently ignition interlock devices are not required until after the second such conviction.

I greatly appreciate the support of the KCMO City Council that on December 2 passed a resolution without dissent stating the City's position on matters that may come up for consideration during the 2022 legislative session that supported passage of Blair's Law.

In this year's regular legislative session I added Blair's Law by amendment to another bill that passed the Missouri House and was recommended for passage without dissent by a Senate committee, but the session ended before it could be taken up by the full Senate. I am optimistic 2022 will be the year this life-saving legislation will finally be enacted into law.

## **WEEKLY CAPITOL UPDATE** Friday, December 3rd, 2021

### DATA SHOWS MASK MANDATES ARE EFFECTIVE

A data analysis conducted by the Missouri Department of Health & Senior Services last month showed that mask mandates in more populous areas of the state helped reduce COVID-19 infections and deaths during the recent delta variant wave, the Missouri Independent reported Dec. 1.

The study was obtained by the Independent as part of an open records request.

Gov. Mike Parson's office requested the analysis in early November, the Independent reported. It compared infection and death rates in St. Louis City, St. Louis County, Kansas City and Jackson County to the rest of the state. Those four jurisdictions had re-imposed mask mandates as the delta variant was sweeping Missouri.

According to the analysis, jurisdictions with mask mandates averaged 15.8 cases per day for every 100,000 residents compared to 21.7 cases per day in unmasked jurisdictions, the Independent reported. The period covered by the analysis ranged from the end of April through the end of October.

In a Nov. 3 email also obtained by the Independent, Health & Senior Services Department Director Donald Kauerauf said infection and death rates are influenced by several variables but that masks are effective in reducing both.

"I think we can say with great confidence reviewing the public health literature and then looking at the results in your study that communities where masks were required had a lower positivity rate per 100,000 and experienced lower death rates," Kauerauf wrote.

The Kansas City and Jackson County mask orders have expired, but those in St. Louis City and St. Louis County remain in place.

Attorney General Eric Schmitt has sued several local jurisdictions, largely unsuccessfully so far, seeking to block their mask requirements.

### JUDGE STRIKES DOWN STATE COVID REGULATIONS

After a Cole County judge declared unconstitutional state regulations empowering local health officials to enact orders aimed at controlling the spread of COVD-19, some local jurisdictions say the ruling doesn't apply to them since their restrictions are based on a state law enacted this year and not the disputed regulation.

On Nov. 22, Cole County Judge Dan Green ruled regulations promulgated by the Missouri Department of Health & Senior Services authorizing local health departments to issues orders aimed at controlling the spread of the disease violate the separation of powers clause of the state constitution.

"This case is about whether Missouri's Department of Health & Senior Services regulations can abolish representative government in the creation of public health laws, and whether it can authorize closure of a school or assembly based on the unfettered opinion of an unelected official," Green wrote. "This Court finds it cannot."

However, the restrictive orders enacted during the pandemic's early months that Green finds constitutionally objectionable expired long ago. Those in place today must comply with a new state law requiring elected local city and county governing boards to approve restrictions and periodically vote to renew them.

The St. Louis Post-Dispatch reported Nov. 30 that some city, county and school officials have said their COVID-related orders will remain in effect despite Green's decision since those orders follow the new law, which the ruling didn't address.

The paper also reported that the Health & Senior Services Department issued a letter to local health officials on Nov. 29 stating that for now its regulations remain in effect since Green has stayed enforcement of his ruling. "It is not currently in effect, as it is stayed by court order for 30 days," the letter says. "Further, there is an appeal pending the decision so this matter is far from determined."

Missouri Attorney General Eric Schmitt has signaled his office doesn't want to appeal the ruling, with a spokesman saying the office is "prepared to enforce compliance with the court's order across the state."

However, since Schmitt's office is not a party to the case but instead is representing the Health & Senior Services Department, the final decision isn't necessarily Schmitt's to make, and the Nov. 29 letter indicates the Department is weighing an appeal. As of Dec. 1, no appeal had been filed.


### LEGISLATOR RESIGNS FOR CHILD ADVOCACY POST

State Representative Becky Ruth, R-Festus, resigned from the House of Representatives on Nov. 30 to accept a gubernatorial appointment as director of the Office of Child Advocate, an independent agency that serves as watchdog over the Children's Division of the Missouri Department of Social Services.

Her first day on the job was Dec. 1.

### Ruth, a real estate agent and retired high school teacher, is best known in the legislature for her work as chair of the House Transportation Committee.

Parson currently isn't expected to call a special election to fill Ruth's vacant House seat, which will be up for election for a full term in November 2022. Ruth was serving her fourth House term and couldn't seek re-election next year due to term limits. Her departure leaves three House vacancies, all previously held by Republicans.







# **South KC Mobile Food Pantries**

Many families in south Kansas City are being forced to rely on community food pantries such as Community Assistance Council's to have enough to eat.

Fortunately, Harvesters (the community food network) brings the semi-truck that serves as its mobile food pantry to seven sites in south Kansas City monthly to distribute fresh produce and other healthy food to families in need. The sites are:

**Center School District,** 8701 Holmes Rd., from 9 a.m. to 10:30 a.m. as long as food is left on the first Saturday of the month. Persons should drive through the bus parking lot to the district warehouse. The event is sponsored by Three Trails Community church in partnership with the Center School District. (There will be no pantry in January.)

**Center District Warehouse, 8701** Holmes Rd., from 11:30 a.m. to 1:30 p.m. the second Friday of each month. Persons should go to the entrance to the Center Administrative Office and drive through the bus parking lot to the warehouse where volunteers will load the food. Persons should take the Troost Ave exit. The event is sponsored by the Center Education Foundation in partnership with the Center School District.

**Evangel Church**, 1414 E. 103<sup>rd</sup> St., from 7 to 8:30 a.m. the second Saturday of the month. Persons may remain in their vehicles, and food will be brought to them.

**United Believers Community Church**, 5600 E. 112th Terr., with vehicles lining up at 8:30 a.m. and contactless food distribution running from 9 to 11 a.m. the third Wednesday of the month.

**Ruskin High School,** 7000 E. 111<sup>th</sup> St., from 4 to 5:30 p.m. the third Thursday of the month. Vehicles should line up on Ruskin Way on the east side of the school, and staff and students will load the food when vehicles reach the school.

**Colonial Presbyterian Church,** 9500 Wornall Rd., with registration beginning at 8 a.m. and food distribution running from about 8:30 to 10 a.m. on the third Saturday of the month. Families are asked to bring two cardboard boxes for volunteers to put the food in.

**Red Bridge United Methodist Church**, 636 E. 117<sup>th</sup> St., our new dates during the holidays are Monday November 29th and Monday December 20th from 2:30 to 3:30 p.m. In the new year we will continue with our fourth Friday of the month in the church parking lot.
