



Dear Neighbor,

I'm extremely pleased to report that the bill I amended on April 12 to include Blair's Law to make celebratory gunfire and any other discharge of firearms with criminal negligence within or into city limits a serious state offense was recommended for passage this morning by a 4-0 vote of the Senate General Laws Committee.

**The amended bill (House bill 944) is now awaiting consideration by the full Senate, and I fervently hope identical versions of it can be approved by both the House and Senate in the five days next week before the General Assembly adjourns Friday, May 14.**

**The House had approved the amended bill on April 19 by a vote of 109 to 36, with 7 legislators voting present.** Because the Senate committee added another amendment to the bill, unless that amendment is stripped off by the full Senate and no other amendments are added by the full Senate, the bill will have to be sent back to the House to consider such amendments, making it more likely time could expire this session before final passage.

**This legislation is named after 11-year-old Blair Shanahan Lane who died after being struck by celebratory gunfire here on July 4, 2011. This morning's testimony for the legislation was extremely powerful, with Blair's mother, Michele Shanahan DeMoss testifying, "Nobody else should have to live through what I've lived through."**

**Major Kari Thompson, commander of the Kansas City Police Department's East Patrol Division, testified the Police Department strongly supports passage of Blair's Law, noting that calls about gunfire on major holidays like New Year's Eve and July 4 are "just overwhelming".**

Major Thompson also stressed that reckless gunfire also is a problem throughout the year.

**As an example she pointed out the death of 24-year-old KCUR radio reporter Aviva Okeson-Haberman who was found unconscious in her apartment on April 23 after being struck by a stray bullet that came through her window.**

This young lady interviewed me when I was first running for this office in the fall of 2019 and asked me to tell her about a bill I intended to introduce if I was elected. I told her about Blair's Law and explained why it was urgently needed to deter reckless gunfire in cities. If the bill had passed last year, perhaps her death could have been averted.

KCPD Sergeant Alane Booth who investigated Blair's death as a detective in the Police Department's homicide unit testified the bullet that struck her when she was outside playing with friends came from celebratory gunfire on the other side of a lake where numerous shell casings were found. **That spot turned out to be over 300 yards away.**

**Both Major Thompson and Sergeant Booth testified that police need stronger penalties to deter such reckless and potentially deadly behavior.**

Currently celebratory and other indiscriminate gunfire in Kansas City is just a city ordinance violation unless there are specified aggravating circumstances. My amendment that was adopted makes the first violation a Class A misdemeanor, the second a Class E felony and subsequent violations a Class D felony.

The original bill that I added Blair's Law to was introduced to allow

discharge of a firearm from a stationary motor vehicle on private property in rural areas to protect livestock from predators.

Other amendments were added to the bill that I didn't support, but with the addition of Blair's Law I firmly believe the amended version will do much more to improve public safety than to weaken it.

### **BUDGET NIXES MEDICAID EXPANSION FUNDING**

Just hours before the constitutional deadline, Missouri lawmakers today granted final approval to the nearly \$35.1 billion state operating

budget for the 2022 fiscal year.

Gov. Mike Parson has until the new fiscal year starts on July 1 to sign into law the various appropriations bills that make up the budget and make any line-item vetoes of spending authority he opposes.

**This year's budget is most notable for what isn't included: funding of a constitutionally mandated expansion of eligibility for the state's Medicaid program to 138 percent of the federal poverty level that will take effect July 1 making an estimated 275,000 additional uninsured Missourians eligible.**

Most Republican lawmakers who have long opposed expansion refused to fund the expansion even though Missouri voters approved the constitutional amendment last year requiring the state to provide Medicaid services to the expanded eligible population.

Despite previously opposing Medicaid expansion, Parson consistently has promised to implement it after last year's public vote. The governor asked lawmakers to provide expansion funding, and his administration earlier this year submitted its expansion implementation plan to the federal government.

**If expansion is implemented as constitutionally required on July 1, without additional funding the Medicaid program will exhaust its spending authority well before the end of the fiscal year, and the legislature likely will be called back for a special session to approve the needed funding. If the constitutional mandate to expand the program is ignored, litigation to require that the constitutional mandate be followed is considered almost certain.**

Under the federal Affordable Care Act, the federal government will pay 90 percent of the cost of expansion – about \$1.4 billion for FY 2022. In addition, implementation will secure an additional \$1.5 billion for our state under the latest federal COVID-19 relief package. Such an influx of spending would create an estimated 80,000 jobs and spark significant economic growth.

**On education, the budget includes an \$8.5 million increase to the**

**\$3.56 billion formula for distributing state funding to local public school districts.** Although that bump is sufficient to claim “full funding” of K-12 schools, that’s only because lawmakers figuratively moved the goal posts a few years ago by drastically reducing the amount of new money required each year to claim full funding. In addition, the budget shortchanges funding for student transportation costs by about \$165 million from what state law says should be allocated.

**After years of either flat appropriations or deep cuts to higher education, the budget provides increases of at least 3.7 percent to the core operating budgets of Missouri’s public colleges and universities.**

**In another budget highlight, the state’s chronically underfunded public defender system is slated for a \$3 million increase that will enable it to hire 53 additional attorneys to represent indigent defendants.** Supporters hope the increased funding will help alleviate caseloads and avoid a constitutional showdown over whether the state is violating defendants’ rights to adequate representation.

### **PRIVATE SCHOOL TUITION AID WINS APPROVAL**

The Senate on May 6 voted 20-13 to grant final approval to a controversial bill creating state tax breaks for donors who contribute to fund scholarships for students to attend private K-12 schools. The legislation initially would cost the state up to \$50 million a year in lost revenue, an amount that eventually could increase to \$75 million annually.

When the House of Representatives originally approved the bill in February, it received the bare minimum number of votes necessary for passage. I voted no. The measure then languished in the Senate for months, causing speculation that it had insufficient support for passage. In the end, it passed the Senate with just two more votes than the bare minimum needed.

**House Bill 349 would allow people to donate to private organizations that in turn would provide scholarships to**

**qualifying students to partially pay for private school tuition. Donors would receive tax credits for the full amount of their contributions, meaning donors would end up being out no money, while the amount of tax revenue the state collects for public education and other services would be reduced.**

While supporters said the legislation would provide opportunities for students to escape struggling public schools, opponents questioned whether many low-income families would actually benefit since they likely would not be able to afford the remaining tuition not covered by the partial scholarships.

Although the bill originally would have applied statewide, in order to win support from more rural lawmakers who feared the negative impact it could have on their local public schools, it was amended to allow only students in more populous cities and counties to apply for the scholarships.

## P-SNAP approved for May

Missouri received approval from the United States Department of Agriculture (USDA), Food and Nutrition Service (FNS) for May Pandemic Supplemental Nutrition Assistance Program (P-SNAP) or Food Stamp benefits. P-SNAP maximizes the amount each household receives based on household's size. The P-SNAP benefit amount includes a 15 percent increase Missouri SNAP households will receive through June 30, 2021. The chart below shows the [maximum monthly SNAP amount](#).

**NOTE:**

*Thanks to the USDA's change to P-SNAP earlier this month, every Missouri household receiving SNAP benefits will get no less than a \$95 P-SNAP benefit for May.*

Persons should go to the entrance to the Center Administrative Office and drive through the bus parking lot to the warehouse where volunteers will load the food. Persons should take the Troost Ave exit. The event is sponsored by the Center Education Foundation in partnership with the Center School District.

**Evangel Church**, 1414 E. 103<sup>rd</sup> St., from 7 to 8:30 a.m. the second Saturday of the month. Persons may remain in their vehicles, and food will be brought to them.

**United Believers Community Church**, 5600 E. 112th Terr., with vehicles lining up at 8:30 a.m. and contactless food distribution running from 9 to 11 a.m. the third Wednesday of the month.

**Ruskin High School**, 7000 E. 111<sup>th</sup> St., from 4 to 5:30 p.m. the third Thursday of the month. Vehicles should line up on Ruskin Way on the east side of the school, and food will be loaded in the vehicles when they reach the school by staff and student volunteers. This event is sponsored by the school and Community Assistance Council.

**Colonial Presbyterian Church**, 9500 Wornall Rd., with registration beginning at 8 a.m. and food distribution running from about 8:30 to 10 a.m. on the third Saturday of the month. Families are asked to bring two cardboard boxes for volunteers to put the food in.

**Center High School**, 8715 Holmes Rd., from 11 a.m. to 1 p.m. as long as food
