SUPREME COURT REVIVES ABSENTEE VOTING LAWSUIT

The Missouri Supreme Court on June 23 revived a lawsuit seeking a declaration that state law allows any registered Missouri voter concerned about contracting COVID-19 from a crowded polling place to cast an absentee ballot without having it notarized.

However, with absentee voting for the Aug. 4 primary already underway, it's uncertain if the case will come to a final resolution before then.

Cole County Judge Jon Beetem dismissed the case in May on procedural grounds but then went ahead and issued a ruling on its merits anyway, declaring that a provision of the state law authorizing absentee voting because of "incapacity or confinement due to illness" doesn't apply to otherwise healthy people who simply want to minimize their chances of being exposed to COVID-19.

In a unanimous but unsigned opinion, the Supreme Court said Beetem wrongly dismissed the case, but having done so Beetem also erred by then ruling on its merits, which wasn't proper on a motion to dismiss. The court ordered Beetem to fully reconsider the case, including any potential impact from changes to Missouri voting laws that were enacted after his original decision.

Gov. Mike Parson signed that legislation, Senate Bill 631 which I voted for, into law June 4. It authorizes registered voters age 65 or over, those who have contracted COVID-19, those who live in a licensed long-term care facility or those of any age who have a medical condition that makes them especially vulnerable to COVID-19, to cast an absentee ballot without getting their signatures notarized.

The bill also creates a vote-by-mail process for all other Missouri voters. However, mail-in ballots must be notarized in person which defeats the purpose of voters trying to minimize contact with other people.

As of June 24, Beetem hadn't yet set a new hearing for the case. Given that Beetem has already ruled on the merits of the case, albeit prematurely, it is possible that after further proceedings he could issue a modified version of his original ruling against the plaintiffs – the state chapters of the NAACP and League of Women Voters. Regardless of how he rules, the case is expected to again be appealed up to the Missouri Supreme Court before reaching a final resolution.

GOVERNOR CUTS ANOTHER \$2.4 MILLION FROM FY 2020 BUDGET

With just one week left in the current fiscal year, Gov. Mike Parson imposed another \$2.4 million in budget cuts on June 23, bringing the total amount of FY 2020 cuts he has unilaterally imposed to nearly \$435.4 million after state revenue collections collapsed due to the COVID-19 pandemic.

Unlike Parson's previous cuts which targeted state funding for local public school districts and higher education, the latest – and mostly symbolic – round of cuts affects the budgets of five of Missouri's six statewide elected officials, along with the Senate and House of Representatives. State Treasurer Scott Fitzpatrick was the only statewide elected official whose budget was spared.

Since the executive offices and the legislature have relatively small budgets compared to state departments, the cuts likewise are relatively minor and not expected to impact their operations during the fiscal year's final week. The cuts are: Senate, \$800,000; House, \$564,165; Secretary of State's Office, \$350,000; Governor's Office, \$250,000; State Auditor's Office, \$200,000; Attorney General's Office, \$200,000; and Lieutenant Governor's Office, \$31,135.

Parson still must take action on the various appropriations bills that make up the FY 2021 state budget before the new fiscal year starts on

July 1. He is expected to make substantial cuts through the use of both line-item vetoes and his budgetary withholding authority. While budget vetoes can only be reversed by legislative override, the governor is able to restore withholdings later in the fiscal year if revenue collections improve.

PARSON FILLS TWO POLICE OVERSIGHT COMMISSION SLOTS

Gov. Mike Parson on June 19 appointed two members to the Missouri Peace Officers Standards and Training Commission. However, six spots remain to be filled on the 11-member panel that oversees law enforcement licensing, training and discipline in Missouri.

The appointments came nearly two weeks after House Minority Leader Crystal Quade, D-Springfield, and Missouri Legislative Black Caucus Chairman Steve Roberts, D-St. Louis, wrote Parson noting that eight Commission slots were either vacant or held by members serving on long-expired terms. With police training and accountability at the forefront amid protests in Missouri and across the world about police conduct, the two legislative leaders told Parson a commission this important couldn't be allowed to continue on autopilot.

Parson appointed Lincoln University Police Chief and Director of Public Safety Gary Hill to one of the vacant slots. Jefferson County Sheriff Dave Marshak is the other appointee and replaces a commissioner who had been serving a term that expired in October 2010 – nearly a decade ago.

Of the remaining commission spots that need to be filled, three are vacant and three are held by people serving terms that expired in either 2016 or 2017. Yet another commissioner's term is set to expire this October.

South KC Mobile Food Pantries

With so many people out of work due to the coronavirus pandemic, a growing number of families in south Kansas City are being forced to rely on community food pantries such as Community Assistance Council's to have enough to eat.

Fortunately, Harvesters (the community food network) brings the semi-truck that serves as its mobile food pantry to four sites in south Kansas City monthly to distribute fresh produce and other healthy food to families in need. The sites are:

Evangel Church, 1414 E. 103rd St., from 7 to 8:30 a.m. the second Saturday of the month. Persons may remain in their vehicles, and food will be brought to them.

Ruskin High School, 7000 E. 111th St., from 4 to 5:30 p.m. the third Thursday of the month. Vehicles should line up on Ruskin Way on the east side of the school, and food will be loaded in the vehicles when they reach the school by staff and student volunteers. This event is sponsored by the school and Community Assistance Council.

Colonial Presbyterian Church, 9500 Wornall Rd., with registration beginning at 8 a.m. and food distribution running from about 8:30 to 10 a.m. on the third Saturday of the month. Families are asked to bring two cardboard boxes for volunteers to put the food in.

Martin City K-8 School, 201 E. 133rd St., from 11 a.m. until food runs out on the third Saturday of the month. This event is sponsored by Three Trails Community church.



Grandview, MO – At 5:00 p.m. on Friday, July 3, Mid-Continent Public Library's Grandview Branch (12930 Booth Lane, Grandview, MO) will close for several months as the facility undergoes a major renovation. Construction at the Grandview Branch, which is estimated to be complete by late spring 2021, will include an expansion of nearly 4,400 square feet as well as a variety of other improvements, including:

- 1. New community programming room
- 2. Three Meeting/collaboration rooms
- 3. New dedicated children's area
- 4. Parking lot repairs
- 5. Improved Wi-Fi coverage and access
- 6. Enhanced entry with automatic entry doors
- 7. New paint, carpet, and ceilings

"We're excited for these upgrades and believe they will prove to be an incredible asset to our community," said Ashley Durkee, Grandview Branch Manager. "While we will miss serving our customers during the renovation, we look forward to welcoming them back into a new and improved library that will enable us to better meet their needs for years to come."

While the Grandview Branch is closed, the Library will direct customers to the Red Bridge Branch (unless customers request a different branch) to pick up materials they have put on hold. Grandview Branch customers are welcome and encouraged to use the services of any other MCPL branch.

This renovation is part of MCPL's ongoing Capital Improvement Plan, which it launched following the passage of Proposition L in 2016. As part of the Capital Plan, all MCPL branches will be improved in some way, and two new branches will be built by the end of 2022. One of the two, the new East Lee's Summit Branch, opened earlier this month.

While the upgrades at each branch have varied based on individual community needs and the building's current condition, the Library's goal is to create more intentional spaces and upgrade essential technology. The Library is working with **Sapp Design Architects**, **Helix Architecture + Design**, and **JE Dunn** to complete all of the work in the Capital Plan.

In addition to all the physical upgrades, the increased funding approved by voters in 2016 has allowed MCPL to expand branch hours, enhance special services, augment early literacy efforts, and buy more materials. **More information about the Grandview Branch and all of the Library's construction projects can be found online at mymcpl.org/Community.**

UNEMPLOYMENT

How to File?

If you're eligible, you'll <u>need</u> the following:

- 1. Your Social Security number;
- 2. Any amount you were paid in the past week, before taxes and deductions;
- 3. The name and mailing address of each job you worked in the past 18 months;
- 4. The dates you started and ended work at each of those jobs.

If this is your first time filing for unemployment please watch <u>this</u> <u>video</u> on unemployment basics. Visit <u>uinteract.labor.mo.gov</u>, create an account and file your claim. If your job loss is related to coronavirus issues, make sure to check a box that says "COVID-19" in your application to waive a requirement to search for a new job amid the crisis.

Missouri provides benefits for up to 20 weeks, which can be extended to 33 weeks under the federal provisions.

The state will pay you up to \$320 per week, and the federal government will provide \$600 on top of whatever you get from the state for each week you're on employment prior to July 31.

Benefits can be paid within 22 days unless there is an issue with your eligibility, which on average can take 4-6 weeks to resolve.

You should continue filing weekly requests for payment even if you have not yet received benefits.

SUBJECT: Reward Increase – 9 Year Old Dominic Young

Homicide

KANSAS CITY, MO --- The Kansas City, Missouri Police Department and the Greater KC Crime Stoppers TIPS Hotline continue to seek information in the January 20, 2018 homicide of 9 year old Dominic Young Jr. at 71 Highway and Emanuel Cleaver II Blvd.

Dominic Young Jr. was apparently hit by a stray gunshot while occupying a vehicle driven by his father and died as a result of his injuries. Dominic, his father and brother were en route to Grandview at the time. The vehicle driven by Dominic's father was hit by gunshots from other vehicles apparently engaged in a gunfight according to statements.

KCPD found a possible crime scene near the intersection where the father said the shooting happened. When the father arrived home in Grandview, Dominic was not responsive. Grandview police initially responded to the father's home and found the boy in critical condition. He was later pronounced dead at a hospital.

A number of community leaders and organizations including State Representative Richard Brown, Mayor Pro Tem Kevin McManus, former City Councilmen Scott Taylor, Scott Wagner, John Sharp; the City of KCMO and Concord Fortress of Hope Church (Pastor Ron Lindsay) have come forward to increase the existing reward in the case up to \$30,000.00. Those leaders are available for comment in regard to the case.
